- Supply, Transportation & fixing of 22W LED down lighter made of die cast aluminum body with powder coating, acrylic diffuser with Driver, operating voltage range of 150 to 265 Volts AC ,Power factor > 0.9 high power 6 Nos of 1 watt having efficacy of>120 lumins/watt etc...Make Crompton./ Philips.
- Supply and fixing of 25 mm dia medium surface P.V.C pipe with IS:9537 part 3 regid with all accessories fixing on chromium plated metallic base saddles including all labour charges etc., complete for run of mains Make: sudhakar/Modi/Atul(DATA)
- Wiring with 2 runs of 14/0.3mm (1.0 sq mm) P.V.C insulated F.R flexible copper cable (ISI MARK) in existing pipe with 6A modular switch fixing on galvanized hot dip switch box covered with appropriate front plate module and ceiling rose, including all labour charges etc., complete for light, bell fan and exhaust fan points in non-residential buildings wires ; havells/HPL(DATA)
- Supply and fixing of 4' fan rods (removing & re fixing of existing fans 8 No's)
