#### **ORDER:**

In the G.Os 1<sup>st</sup> to 12<sup>th</sup> read above, Government have issued orders recognizing the sports disciplines and the priority of achievements to be followed and considered for eligibility for seeking admissions into various professional courses in the state.

2. In pursuance of the orders of the Hon'ble High Court in W.P. No. 22700 of 2018 vide reference 13<sup>th</sup> cited and after careful examination, Government have constituted a Committee under the Chairmanship of VC & MD, SATS vide reference 14<sup>th</sup> cited above to make suitable recommendations for evolving a sound criteria for admissions into professional courses under Sports Quota.

3. In the reference 15<sup>th</sup> read above, the above said Committee has submitted its report to the Government duly studying the guidelines issued in G.O.Ms. No.7 and the directions of the Hon'ble High Court in W.P. No.22700 of 2018 for implementation of sports quota for admission into professional courses.

4. The Government, after careful examination of the Committee recommendations and **in supersession of all earlier G.Os.** in the references cited, has decided to continue the Sports Quota with the existing **0.5%** (1/2 percent) reservation **IN ALL THE PROFESSIONAL COURSES <u>EXCEPT MBBS & BDS</u>**, i.e., Engineering, Agricultural, IIIT, B-Pharmacy, ICET, ECET, B-Arch, MBA, EDCET, PECET, LAWCET, DIETCET, POLYCET, ITI by implementing the quota in the following 31 (Thirty One) Sports Disciplines:

#### 5. GUIDELINES:

The following guidelines are to be followed for implementation of Sports Quota:

- a) Priorities shall be accorded to the candidates basing on their best performance of last 5 years verifying the genuineness of certificates (from the age of 10 years to 19 years only) for according priority to under graduate courses and Date of Birth shall be tallied proportionately to the category of age group vis-àvis the concerned sport. The date of birth certificate issued by the SSC board/Similar Boards of Central/State Governments only shall be entertained as proof of age.
- b) <u>The candidates shall necessarily possess the minimum pass mark</u> for such entrance test i.e. eligibility test under sports quota to claim the admissions, basing on the level of Highest achievement.
- c) Representation/Participation in any Game/Sport by a candidate after passing the qualifying examination shall not be considered.
- d) Sports Achievements certificate at higher level shall be considered only when it is supported by the lower level competitions to the satisfaction of Scrutiny Committee in terms of same level lower official tournaments/bodies etc.,
- e) Participation in Open Tournaments/Invitation Tournaments/un authorized meets i.e. which are not mentioned in this G.O. will not be considered.
- f) Any International achievement/participation may be considered, when only such certificate was issued by the Competent Authority who had conducted the event.

- FORM-I : For the International Championships (Medal & Participation) issued by the Federation
- FORM-II : For Association Nationals competitions (National/South Zone Medals/Participation and State Medals issued by the State Association.
- FORM-III: For Universities Championships (Inter collegiate, South Zone University All India/World Inter Universities issued by the Universities)

FORM-IV: For SGF, Central Government schemes, for all remaining Events like World/Asian school games, National/State level /Inter District games issued by the DEO/DYSO/Secy.SGF /SATS official.

9. The list of the selected candidates approved by the Evaluation Committee **SHALL BE FINAL** and forwarded to the concerned Universities/Institutions for the admissions under Sports Quota.

#### **10. ACTION TO BE TAKEN FOR FURNISHING OF FALSE** CERTIFICATES

Not only the Candidates who submit false certificates shall be liable for criminal action but also his/her parents shall be held responsible. Further the admission obtained with such false certificates shall get cancelled at any point time.

11. In case of false certification or attestation by any concerned state Association, the said Association shall be disqualified for 3 (three) years besides criminal prosecution against the signatory of the false certificate. The said Association shall not be extended any financial support and any facilities by the Sports Authority of Telangana State and State Government during said period of disqualification.

12. The above orders shall come into effect immediately.
