**Envelope „A”:** Non refundable processing fee of Rs.2,000/- (Rupees Two thousand only ) in the form of Bank Demand Draft in favour of Director, RGUKT Basar payable at Basar be submitted in Envelope „A”. Tenders with cheque(s) will be rejected.

**Envelope „B”** Tender document, complete in all respects duly signed by the tenderer, along with the all supporting documents and list of samples of Kabaddi Mat be submitted in Envelope „B”.

Envelope „C” Rates be quoted (Financial Bid) as per proforma. The following also have to be submitted

- a. Copy of GST Registration Certificate.
